Waitsfield Cemetery Commission Meeting Minutes

- 1. Welcome and agenda review: Robin M
- 2. Public comment: no public present
- 3. Review and approve minutes of May 6, 2025 Meeting Minutes: unanimously approved.
- 4. President's: report Robin M (see old business)
- 5. Treasurer's report Nancy. Unanimously approved.
 - a. CD matured 6/5/25. Accumulated \$604.10 in interest (from Oct. 24-June 25)
 - b. Ordered new checks.
 - c. Deposited CD total amount of \$20,669.10 into WCC checking account. WCC account balance= \$25,077.63 on 6/5/25.
 - d. Robin M. will work on cash flow statement.
 - e. Waitsfield Cemetery Trustees will be giving WCC \$20,000 soon.
- 6. Sexton's report: George. Unanimously approved.
 - a. Ordering new chain: 3" link is what is currently in place. George Jr. will research the cost and email the price to the WCC.
 - b. Update on Headstone repairs: Robin M. reviewed headstones that were repaired and "not completed" repairs. Robin M. will follow up with Jeff Pignona to discuss the incomplete repairs.
 - c. Cornerstones: In the future George Jr. will order the cornerstones as needed. We now charge \$25 a set. Robin M. will have a conversation with Jeff Pignona about cornerstone designs...Standard cornerstones are initials, special requests for different cornerstone designs will be considered. George will speak with Matt Fitzgerald about cornerstone pricing and options.

 Jeff Pignona called George about an unpaid WCC invoice #166. George cleared this up, proving that the invoice had been paid.

- b. Gravestone cleaning: Robin P. assembled two kits for gravestone cleaning. Robin P. will keep them in her garage. Robin P. will try it out and send the WCC a link to the video how to for gravestone cleaning.
- c. Fencing for the Irasville Cemetery: Laura This project is on hold until Waitsfield waste water project is completed, probably in 2026..
 - From Misha Golfman: The Mehuron's spur is tied to the wastewater project. Once they connect to the wastewater line, they will disassemble their old leach field, regrade and reorganize the entire area, and make room for the path.
